### **Annual Awards–Nominees Requested**



# **October General Meeting Recap** *"WE HAVE A PROBLEM!"*



Midway in his talk about water issues that face residents of Yavapai County, Ed Wolfe, PhD., sounded the alarm. The effects of the 2% annual increase in population

since 1970, the proposed construction of an additional 16,000 homes, and the current overdraft of the aquifer by 252,000 acre feet a year are creating severe water issues for state and local governments, business and industry, and residents alike.

Dr. Wolfe, one of the founders of the Citizens Water Advisory Committee (CWAG), an active member of the Verde River Watershed Partnership, referred to history as he explained the significant reduction in groundwater in the county. Del Rio springs brought the first settlers to central Arizona. Expansion, farming and ranching ultimately exhausted the supply of fresh spring water, and what at first seemed a suitable place for the capital of the state became an example of mismanaged water resources. Del Rio Springs, which feeds the Upper Verde River, will be dry by 2025. Six miles of the perennial river has been lost.

Dr. Wolfe encouraged AAUW members and their friends to advocate for water conservation, to plant drought- resistant landscaping, and to capture rainwater for irrigation. We each can do our part, however small, to address the problem.

## **Public Policy**

The Public Policy Committee (PPC) has been energized in September and October with monthly meetings, a Ballot Initiatives Forum, the AAUW Arizona Fall Forum, and efforts to enhance advocacy.

### **Ballot Initiatives Forum**

**Next Meeting:** All are welcome to the next PPC meeting **Tuesday, Nov. 6, from 1 to 3 pm in the Elsea Room at the Prescott Public Library**. The speaker will be Art Atonna, a Prescottonian who spearheaded the recent "dirty money" campaign. Atonna will share insights from that effort and the Citizen's Initiative Process. A discussion about Alliance Creation will follow.

The **December 4** PPC meeting will feature a talk on the Equal Rights Amendment with discussion regarding an action plan for branch advocacy on all issues.

More than 100 interested citizens attended the Ballot Initiatives Forum held Sept. 29 at Yavapai College sponsored by AAUW in conjunction with the area League of Women Voters (LWV). Speakers from AAUW and LWV presented the pros and cons of the November ballot initiatives, based on a Voter's Guide prepared by LWV. The guide is available on the AAUW Prescott Public Policy page. Also introduced were Prescott Unified School District board candidates, including AAUW Prescott's own Deb Dillon, who said her focus is the kids.

## The Opioid Crisis

Opioids are painkillers such as Vicodin, Oxycontin and Codeine, which have the same active ingredient as the less expensive street drug heroin, according to Laura Norman, Chief Development &

Communication Officer for West Yavapai Guidance Clinic. Norman spoke at the October Public Policy meeting.

With more than two Arizonans dying every day from opioid overdose by June of 2017, Gov. Doug Ducey declared a statewide public health emergency. One year later, the state of emergency was lifted.

In July of 2018, 45 percent of people with suspected opioid overdoses in the prior month had received prescription opioids from 10 or more prescribers in the past year. Starting January 1, 2019, Yavapai County will require Electronic Prescribing of Controlled Substances to establish a centralized database and eliminate paper scripts.

## Public Policy Plan for 2018-2019

Aligning its efforts with the AAUW mission "to advance gender equity for women and girls through research, education and advocacy," the Public Policy Committee (PPC) has identified multiple paths to "move from education to advocacy."

Each committee meeting will be designed around a speaker/presentation on a timely topic, followed by relevant discussion among attendees about actions that could be taken going forward to positively affect outcomes vis-a-vis the topic.

Of primary focus is the committee's concern about "the will of the branch" in becoming more active on issues of importance to AAUW constituents. Additional effort will be allocated to organizing opportunities in which the general membership will be encouraged to learn more about and/or participate in advocacy.

A written strategy and implementation plan will be created to guide the PPC's work for the coming year. Understanding the ballot initiatives process in Arizona and how to best create alliances with likeminded individuals and organizations are among potential approaches to be evaluated for inclusion in the local Public Policy strategic plan. Speakers will be invited to guide the PPC in these efforts.

Other topics identified for future speakers include advancing the Equal Rights Amendment (ERA); identifying career and technical education opportunities for young women; establishing a dedicated funding stream for education in Arizona; and supporting security/retirement planning to help optimize income streams and control expenses.

## **AAUW Arizona Fall Forum**

The AAUW Prescott Branch was well-represented at the AAUW Arizona Fall Forum October 6 in Mesa. Ten Quad Cities' members attended the event, which included presentations on dark money, civil discourse, and the Equal Rights Amendment (ERA).

*Dark Money:* State law has limited the amount of money that corporations and unions can spend on political campaigns, but there is no requirement to disclose the source of those funds. Voters, therefore, are encouraged to identify what or who is behind political ads.

*Civil Discourse*: Suggestions for respectful communications include approaching with curiosity, practicing active listening, agreeing to disagree, finding areas of agreement, and practicing staying calm. Asking probing questions, requesting clarification, and paraphrasing are techniques to deescalate conflicts. The focus should be on what the other person is saying, not what the listener is going to say next.

*ERA*: There was a time when men would publicly ask women in educational and career settings why they were taking up space that theoretically belonged to men. Women must get better at communicating what is important to them. Sharing equal rights experiences across generations is one method.

genres. Excited by the world that was revealed through their pages, she enrolled at nearby Red Rocks Community College.

Transferring to a four-year school, Loretto Heights College, she

earned a degree in Environmental Management. After attending

During her tenure, she will encourage our public interface. She seeks to enhance our Public Policy activities by forming a subcommittee that will explore Prescott from a public policy perspective. She will also look for additional opportunities to partner with the League of Women Voters and to continue the multi-faceted relationship with Yavapai College.

## **AAUW Photographers**


### Expose the World, by Gail Shay
