#### Arizona's Energy & Economic Future



Former Arizona Corporation Commissioner and ASU Professor Kris Mayes will discuss the opportunity for Arizona to advance its economy, conserve precious water supplies, and improve its air quality through

the deployment of clean energy

sources such as solar, wind and energy efficiency. Mayes, who co-authored Arizona's most sweeping clean energy laws during her time on the Corporation Commission, will discuss how the state could boost the amount of renewable energy required of the state's utilities such as Arizona Public Service Company from the current 15 percent to 50 percent, saving ratepayers hundreds of millions of dollars while creating thousands of high-paying jobs. She will also outline how a focus on clean energy should be one of Arizona's most important strategies in the fight to conserve groundwater. Mayes will talk about the need to reform the way utilities do business - from merely providing a commodity - energy - to providing energy services, as more and more Arizonans seek customer-sited energy solutions such as rooftop solar and battery storage. Finally, Professor Mayes will discuss where Arizona ranks among states in the West for clean energy advancements.

## **CONGRATULATIONS TO LUCY** FIELDS – AAUW MEMBER FOR 50 **YEARS**

It is not often when an AAUW member receives recognition for 50 years of membership. This year our Prescott Branch is honoring one of its own -Lucy Fields. In response to a request for information so that we could tell her story at our



Holiday Brunch, Lucy wrote her personal AAUW history. Below is a lightly edited version of that history. We congratulate Lucy for her ongoing commitment to AAUW...and may it continue for many more years. Retold by Becky Gunn.

# Lucy Fields Describes Her AAUW Life:

When my daughter was about 3 years old, I needed some adult stimulus. AAUW in Arcadia, California offered a broad variety of general programs for young women and an interest group aimed especially at moms of young children. It was called "Juniors Group". As our children grew older, we renamed our group the "Night Owl Group." At that time, I also participated in the "Book Group" and was chairwoman one year. It was a dinner group that met at a restaurant and also reviewed books. Even when I went back to work full time, I continued to be active in the Branch.

In 1986, we moved to Palm Springs, California. I was teaching there but also wanted to get to know more people in the community. I transferred my AAUW membership to the Palm Springs Branch. The big fundraiser for the Educational Foundation at that time was a Home Tour each year. I helped with that as well as participated again in their Book Group. Other committees found me working at various tasks. Of course, luncheons were always popular occasions.

1990 found us in Prescott where we had planned to live for 3 years just to experience the lifestyle. Knowing that the easiest way to make new friends in AAUW Prescott Newsletter

a new town was to join AAUW, I decided to have dual membership in Prescott and Palm Springs. We kept our home in Palm Springs and planned to go back and forth. As I became more involved in the *Prescott Branch, and we kept living there, I dropped* my dual membership and only belonged to the Prescott Branch. I served on the Board for quite a few years in different assignments. I was a treasurer and membership chair, as I recall. There were several interest groups that I was involved with. *Couples dinner group and book group are among* those that I attended.

In the mid ninety's, I went to work full time at Head Start in Chino Valley. I had been subbing for Prescott Unified School prior to that. My husband was retired and was involved in playing clarinet for several bands in the area. All of these activities kept us very busy and obligated.

**Charter Schools: Public Forum Opportunity** 

AAUW-Prescott's Board member Deb Dillon has been researching charter schools to identify what they are, how they operate in Arizona, and their impact on the Prescott area. Dillon, a member of the Prescott Unified School District (PUSD) Board, plans to share her findings with the board, district leadership and staff, legislators (in the local area and beyond), the media, and the public in general. She anticipates finishing the report around January. Utilizing Dillon's framework, PPC is exploring hosting or co-hosting a public forum in 2020. Potential speakers include Dillon and area school officials.

**Fall Forum 2019** AAUW-Prescott was represented at the state AAUW Fall Forum this year by five members: Patti Allen-LaFleur, Becky Gunn, Lynne Murphy, Edi Taylor-Richards, and Jeanette Polvani.

**Boost to ERA Ratification in Virginia** Seat changes in the Virginia House and Senate during the November 2019 elections bode well for the state's becoming the 38th and milestone state to ratify the Equal Rights Amendment (ERA). VAratifyERA cites new leadership in the House and a preponderance of "equality candidates" winning seats in both houses as evidence of the increased probability of ratification. For the 2020 legislative session, 55 legislators in the House of Delegates and 26 senators are anticipated to be staunch supporters of the ERA. A September 2019 poll by the Washington Post-Schar School reports that 83 percent of Virginians support ratification of the ERA.
