During her career, Katreena has been awarded the National Top Ten Businesswomen from the American Business Women's Association, the Arizona Association of Career and Technical Education's Visible Difference Award and the Target Training International's President's Award.

Flat Tax Budget in Arizona Explained

At the end of the recent legislative cycle in Arizona, a Flat Tax was approved, along with Senate Bill 1783 that creates a new small business tax category. The flat tax creates a \$1.5 billion permanent decrease in revenue each year. For individuals, the Flat Tax is 2.55% on taxable incomes up to \$27,272 and 2.98% on taxable incomes above \$27,272. For married couples filing jointly, the Flat Tax is 2.53% for taxable incomes up to \$27,272 and 2.75% for taxable incomes above \$27,272. Ninety-one percent of the tax savings will go to the top 20% of earners, and well over half of that (53%) will go to the top 1% of earners. The wealthiest Arizonans will pay 1.0% income tax on highest earnings while everyone else will pay 2.5% income tax.

The Tax Cap was proposed in response to Proposition 208, Invest in Education, approved by voters

in November of 2020, which includes a 3.5% income tax surcharge on earnings over \$250,000 single filers/over \$500,000 joint filers. With implementation of the Tax cap, rather than boosting the total top income tax to 8% as included under Proposition 208, high earners will be capped at 4.5% total. They would pay the tax surcharge at 3.5% but their income tax would be capped at 1%.

As our Public Policy Committee promotes dedicated, equitable and adequate funding for public education in Arizona, we continue to monitor how the state budget impacts our public schools. In lieu of receiving close to \$900 million annually from Proposition 208, the reduced investment in education will be \$400 million annually. Returning income taxes back to former levels will be virtually impossible, because raising taxes requires a 2/3 vote of the legislature.

Education groups are preparing to go to the ballot in response to the Flat Tax, along with Senate Bill 1783, having voters approve three referendums to prevent the Flat Tax from going into effect. If the education coalition can collect the minimum of 118,823 signatures within 90 days of the session adjournment, it would put a freeze on implementation of the tax cut. Then, on the ballot in November of 2022, Arizona voters would decide if they want to allow these tax changes to go into effect.

Scholarship Fundraising News

On and Off the Wall-an AAUW guide to Public Art in Prescott– will be available in September.

Prescott is fortunate to have dozens of examples of sculpture, memorials, and murals in public places, easy to find and interesting to study. The Scholarship Committee has prepared a guide which includes descriptions and locations of some of these pieces throughout Prescott, so contributors can plan walking or driving adventures to appreciate them for the first time or re-visit favorites.

The guide, entitled *Art On and Off the Wall*, will be available for a contribution of \$25 on Friday, Sept. 17. It can be downloaded onto an electronic device for viewing or printing. Information about this fundraiser, making contributions, and receiving the link to the guide will be forthcoming.

All proceeds will go to the AAUW Centennial Scholarship at Yavapai College, which is awarded to women students pursuing a career in STEM (Science, Technology, Engineering, and Math) fields.
