

National AAUW Dues are Set to Increase by \$5; Local and State Dues will Remain the Same



The AAUW membership year is from July 1st through June 30th. Members should be receiving an email regarding renewal in April. National Dues are going up \$5, which will bring the membership dues up to \$103.00.

Public Policy

Public Policy advocates statewide are watching to see if the Arizona Legislature will approve a waiver to restore a devastating 16 percent cut of 1.2 billion dollars to school district budgets triggered by a reduction of 50,000 students enrolled and that a sales tax for schools is no longer exempted from the state constitutional cap in the fiscal year 2022.

The legislature's 2022 session convened on January 10 and will adjourn May 13. Since the cumulative total in Arizona's education budget for the fiscal year 2022 exceeded the state's \$6.6 billion voter-approved constitutional cap, known as the Aggregate Expenditure Limit, set in 1980 for education, the waiver must be granted no later than March of 2022 to affect the districts' April 1 budget deadline. As employment decisions are made in early March by school boards, passing a waiver before March 1 is desired. Arizona school districts were notified in October 2021 that their budgets would be reduced by 16 percent, amounting to \$1,300 per student. Charter schools are not impacted.



While there has been a recent infusion of federal dollars to address the impact of learning loss from COVID, public schools have been allocated these one-time dollars from the federal government to counter the negative impacts on learning from the pandemic, the funds come with restrictions. Specifically, the money is limited to improving infrastructure, such as ventilation and technology, and allocating temporary employees to address learning loss among students.

The non-pandemic state budget is essential to address ongoing education expenses, including essential teaching positions. Without legislative approval of a budget exemption, known as a waiver, to restore the short-changed 16 percent to each school district, significant cuts to general expenditures will be implemented for the fiscal year 2022 education budgets. The likely outcome is "Reduction In Force" notices to some teachers that their positions have been cut and closing of schools.

AAUW-Prescott's Public Policy Committee advocates that state funding for public education (district and charter schools) be raised at least to the national average per student, and that uniform operational, budget, and reporting requirements be enforced equally among all public schools. The state's K-12 education system currently receives \$3.5 billion less in funding than the national average.

Together, we continue to advocate for dedicated, equitable, and adequate funding for public education in Arizona, and now especially, the waiver to override the constitutional budget cap spurred by federal pandemic relief.

Update: The Arizona Senate waived the education spending cap, 23-6 on February 21, 2022.
